Families First Coronavirus Response Act (FFCRA)

- Waiver for School Year (SY) 2021–22 for USDA Foods entitlement calculation
- Current entitlement calculated based on SY 2018–19 lunch counts instead of SY 2020–21 lunch counts





Entitlement for School Year (SY) 2021–22


- Entitlement: **\$218,320,757**
 - Meal rate: \$0.3975 (SY 2020–21: \$0.37)
 - SUPER: **\$93,339,185**
- DoD Fresh Entitlement: \$47,557,000
- Unprocessed Fruit and Vegetable Pilot Entitlement: \$3,268,750







DoD and Pilot 41%



DoD Fresh SY 2020–21

- California
 - 375 agencies and two state warehouses
 - \$76,794,630 spent
 - 2.7 million cases/61.2 million pounds
- SUPER
 - 200 members
 - \$30.2 million allocated
 - \$45,727,559 spent
 - 1.635 million cases/36.2 million pounds ordered





DoD Fresh SY 2021–22

- California
 - 417 agencies and two state warehouses
 - \$47.5 million allocated
 - 63 percent spent
- SUPER
 - 196 members
 - \$26.9 million allocated
 - 70 percent spent

 - Distribute February 2022
 - Due early March 2022
- Requests placed with the USDA
 - First orders due late March 2022
